

•Companies must not have a major partnership with another large biopharmaceutical company

Companies must be focused on new target concepts or drug discovery

How to Apply

Applicants must provide a non-confidential deck of no more than ten slides. Slides must address unmet medical need, solution, scientific principal, key data supporting the scientific principal, overview of business case, and intellectual property.
